- Grounds Manager—Ben McCaslin provided the board with a written report. Reported that things have been going well. Needs someone to dig up the water shut off for the north wash rack as it would not shut off and would like to get dirt to fill holes in the horse stalls. Started winterizing and putting away some of the items like trash cans and picnic tables that won't be used until spring. McCaslin asked if he could purchase aluminum planks to replace the bleacher seats. Pres. Nelson asked if McCaslin will come up with a skid to put under the bleachers.

### **NEW BUSINESS:**

**Disc/dec -** Winter Ball Planning/Organization

Hartman asked Charmaye Popp about her and Tracy Popp taking the lead on the collecting donations and getting things in line.

Tracy Popp is willing to help this year but is open to others helping that might be willing to take it on in the future.

Ryan asked for a budget for purchasing the guns for the auction. Board consensus was to stay around \$1200.

**Disc/dec** – Purchase floor cleaner for Building 18

**Disc/dec** – Mid-States Rodeo Association Finals 2023

Pres. Nelson said that Michelle had talked to Jill Austin after they received the invoice as they were billed for the sponsor tickets that they provided their own sponsors. They said they will pay the invoice, but it will be after the first of the year before they are able to pay it.

#### **OTHER CONCERNS:**

Kori from Jones Insurance sent an email to notify us that our account has been credited \$2200 from a reclassification of buildings that better reflect the structure of the building. That credit has been applied to the November invoice.

There is an outstanding check to Mead Lumber—Shanon will reach out to the accountant to stop payment and reissue check.

There are also outstanding invoices—the board asked Shanon to just send the invoices again.

Mona Weatherly said that the Custer County Chief is publishing "Who's Who in Business" in magazine form. Businesses can advertise their services. Hartman will work with Weatherly for this project.
